

**SUMMARY ANNUAL REPORT
FOR
A BEKA BOOK, INC. 401(K) RETIREMENT PLAN**

This is a summary of the annual report for the A Beka Book, Inc. 401(k) Retirement Plan, EIN 59-3391229, Plan No. 004, for the period January 1, 2024 through December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through insurance and a trust fund. Plan Expenses were \$1,900,748. These expenses included \$1,860,657 in benefits paid to participants and beneficiaries and \$40,091 in other expenses. A total of 324 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$18,505,820 as of December 31, 2024, compared to \$17,051,261 as of January 1, 2024. During the plan year the plan experienced an increase in its assets of \$1,338,661. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$3,239,409 including employee contributions of \$735,861, employer contributions of \$534,333, rollover contributions of \$4,503, there is also a transfer in of \$123,615, and transfer out of \$7,717.40 and earnings from investments of \$1,964,713.
