Is Christianity **Dying?** Jeffrey T. Kuhner



Once the bastion of Western civilization, now, Christianity is a pitiful remnant of its former greatness. Across the West, it is in full retreat....

Many Protestant denominations are abandoning their beliefs and fervent missionary zeal, embracing chic environmentalism and watered-down socialism as a cheap substitute for the traditional Gospel. Europe, the ancient stronghold of Christendom, has been transformed into a secular neo-pagan culture. For Europeans, God is dead; He has been replaced by materialist man.

Christianity is gradually being purged from the public square. Once America loses its Christian identity, it will lose its freedoms.

The secular tidal wave has also hit and overwhelmed America. Since the 1960s, the United States has been the victim of the sexual revolution that glorifies hedonism and personal liberation....

The left is determined to extirpate Christian holidays and symbols from our society. Liberals are determined to smash traditional values and drive Christians underground. The American left is following in the shameful—and much more bloody—footsteps of Marxist regimes. Instead of eradicating religious faith through the barrel of a gun, leftists use bureaucratic dictates and mass propaganda.

The result is the same. Christianity is gradually being purged from the public square....

The same standards do not apply to Islam.... Multiculturalists would never dare to remove say, Ramadan, from the calendar and rename it “Fasting Month” for fear of offending Muslims—and possibly triggering a fatwa. Self-preservation—and cowardice—dissuades them from attacking certain religions.

The Founding Fathers emphasized the constitutional republic depended on a vigorous religious society.

“Our Constitution was made only for a moral and religious people,” said John Adams. “It is wholly inadequate to the government of any other.”

The Founding Fathers were not secularists. On the contrary, they were devout Christians (with the exception of some Enlightenment deists like Thomas Jefferson), who feared an established church—especially, the Church of England—which persecuted dissenters. They would regard it as bizarre and repulsive were they to witness how the concept of the separation of church and state would be twisted in our time into a form of radical secularism and anti-Christian bias.

Editing Out ~~God?~~

Barack Obama [three times] recently edited out of the Declaration of Independence the word “Creator.” It should be clear to all Americans he doesn’t approve of the nation’s founding document in its entirety.

The most familiar passage of the Declaration is the part that says: “We hold these truths to be self-evident, that all men are created equal, that they are endowed by their **Creator** with certain unalienable Rights, that among these are Life, Liberty, and the pursuit of Happiness.”

It is the creed upon which America was founded. It is what sets America apart from the rest of the world. It is the nation’s mission statement. It is the cornerstone upon which the Constitution rests. Strike one word, however, and it changes the meaning significantly.

That’s what Barack Obama is trying to do—and he’s not alone. It seems there is a concerted effort to rewrite America’s historical documents, not just rewrite history, but actually change the words spoken and written by our forefathers.

As *World Net Daily* reported recently, the American Constitution Society is distributing copies of Abraham Lincoln’s Gettysburg Address minus the words “under God.” Coincidence? I don’t think so.

In response to President Obama's speeches (p. 3), members of Congress wrote this letter and entered it into the public record —

Dear Mr. President:

We write today in response to a speech given on November 10, 2010, at the University of Indonesia in Jakarta, Indonesia, in which you stated, "But I believe that the history of both America and Indonesia should give us hope. It is a story written into our national mottos. In the United States, our motto is *E pluribus unum*—out of many one...our nations show that hundreds of millions who hold different beliefs can be united in freedom under one flag."

E pluribus unum is not our national motto. In 1956, Congress passed and President Eisenhower approved the law establishing "In God We Trust" as the official national motto of the United States. This motto is also referenced in our national anthem and is engraved on our coins and currency.

Additionally, during three separate events this fall, when quoting from the Declaration of Independence, you mentioned that we have inalienable rights, but consistently failed to mention the source of the rights. The Declaration of Independence definitively recognizes God, our Creator, as the source of our rights. Omitting the word "Creator" once was a mistake; but twice establishes a pattern. In your speech in Indonesia, you mentioned being unified under one flag. The Pledge of Allegiance to our flag says that we are "one nation under God." As President of the United States, you are our representative to the rest of the world. By misrepresenting things

as foundational as the Declaration of Independence and our national motto, you are not only doing a disservice to the people you represent you are casting aside an integral part of American society.

John Adams said, "It is religion and morality alone, which can establish the principles upon which freedom can securely stand." If Adams was right, by making these kinds of statements to the rest of the world, you are removing one of the cornerstones of our secure freedom. If we pull the thread of religious conviction out of the marketplace of ideas, we unravel the tapestry of freedom that birthed America.

As members of the Congressional Prayer Caucus, a bi-partisan group of 68 Members of the United States House of Representatives, we are dedicated to preserving America's religious heritage and protecting our religious liberty. We respectfully request that you issue a correction to the speech you gave, as it does not accurately reflect America and serves to undercut an important part of our history. We are willing to meet with you to discuss this further if you would like. As President Ronald Reagan warned, "If we ever forget that we're one nation under God, then we will be a nation gone under."

Shariah

The Threat to America

The Center for Security Policy

Even a fairly superficial reading of the Quran and other primary source documents of **shariah** reveals that it is a political-military-legal doctrine, rather than a religion.... The prominent Islamic scholar Abdul Mawdudi concurs with this assessment, saying:

“But the truth is that Islam is not the name of a ‘Religion,’ nor is a ‘Muslim’ the title of a ‘Nation.’ In reality,

Islam is a revolutionary ideology seeking to alter the social order of the whole world.

Islam is a revolutionary ideology and programme which seeks to **alter the social order** of the **whole world** and rebuild it in conformity with its own tenets and ideals.”

Opposing Ideologies

Shariah is, moreover, a **doctrine** that mandates the **rule of Allah** over all aspects of society. Specifically, in contrast...with the Virginia Statute for Religious Liberty, shariah holds that God did not create the mind free, but in subservience to the will of Allah (as detailed in shariah). The condition of human beings is **submission to Allah**, not freedom....

The shariah legal code cannot be insinuated into America...without violating the Constitution’s Article 6 Supremacy Clause, which requires that the Constitution “shall be the supreme Law of the land.”...

Shariah demands that Islam must not be “disrespected.” And Islam

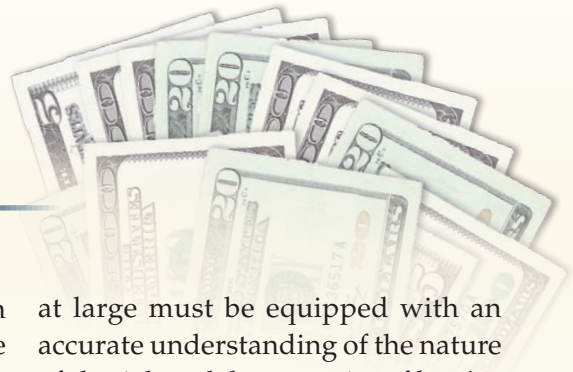
is *not* “disrespected,” according to Western practice. There is more than etiquette at work here; there is **fear**.... It “puts the Western public sphere in...prohibition of Christians and Jews to criticize Islamic history and doctrine.”

The West is the source of liberating ideas of individual liberty, political democracy, the rule of man-made law, hu-

man rights and cultural freedom. It is the West that has raised the status of women, fought against slavery, and defended freedom of inquiry, expression, and conscience. The West needs no lectures on the superior values of societies that keep their women in subjugation,...stone them to death for alleged adultery, throw acid on their faces, or deny the human rights of those considered unacceptable to a savage, omnipotent deity....

Stealth Jihad

By manipulating perceptions at the national strategic level about the nature of shariah, the enemy can actually exercise profound influence over the nature and adequacy of the defense mounted. That is most especially true of actions needed to contend with the **Muslim Brotherhood’s** stealth jihad—even though we know its avowed purpose is aimed at “eliminating and destroying



the Western civilization from within and ‘sabotaging’ its miserable house by their hands.”...

To cite but one example, on May 8, 2007, then-Homeland Security Secretary Michael Chertoff met with a group of self-styled Muslim-American “leaders.”...

The host’s stated purpose was to discuss ways the Department can work with the Muslim-American community in the interest of protecting the country, promoting civic engagement, and preventing violent radicalization from taking root in the United States. The Muslim participants, however, used the occasion

to inveigh against U.S. officials for using terminology the Ikhwan finds offensive—even though, indeed *precisely because*, it accurately describes terrorists who invoke Islamic theology in planning, carrying out, and justifying their attacks. As discussed, the Brotherhood routinely dissembles about the validity of this connection and darkly warns that even discussing that possibility will insult and provoke Muslims....

Shariah on Wall Street

For some time now...Wall Street has been marketing SCF [Shariah-Compliant-Finance] as little more than a kind of “hot,” “new” product for American pension funds, insurance companies, and corporations. Investment banks and other financial institutions have been hiring Muslim religious authorities to sit on corporate SCF advisory boards that directly influence the investment of billions of U.S. dollars....

The Treasury Department and other agencies of the U.S. government have been warned repeatedly and in detail that—whether it is called “Islamic Finance” or the more clear “Shariah-Compliant-Finance”—SCF is used to **legitimate** and facilitate the penetration of shariah. As such, it is inherently antithetical to American law.

Unfortunately, to date, neither Treasury, the Securities and Exchange Commission, the Federal Reserve Board, nor the rest of the federal government has recognized this reality about either shariah or SCF, the financial component of jihad. In fact, in response to a brief, a senior official actually had the temerity to say to a critic of SCF, “I don’t know what shariah law is, but it can’t possibly be what you say it is.”

The willful blindness of Treasury officials regarding the threat to U.S. national security posed by Islamic Law constitutes professional malpractice, at a minimum.

AIG: A Case Study

In September 2008, at the height of the U.S. financial crisis, the U.S. government used more than \$180 billion of taxpayer funds to buy 79.9 percent of the preferred shares of American International Group (AIG)—a massive insurance company deemed “too big to fail.” **That purchase made every American taxpayer a part-owner** in a company that aggressively promotes SCF. Indeed, AIG is the largest purveyor of shariah-compliant insurance products in the world, thanks to its so-called *Takaful* (or SCF) division that has sold such shariah-based insurance products since 2006. Its Sun America, AIG Financial Services Corp., and other divisions also deal in shariah financial instruments.

In December 2008, the Michigan-based Thomas More Law Center and attorney David Yerushalmi, a litigator expert in security transactions and shariah-compliant financing, filed a

lawsuit against the Treasury Department and the Federal Reserve Board alleging that **AIG is promoting Islam** in violation of the First Amendment’s Establishment clause. This constitutional provision requires the separation of church and state....

Wittingly or unwittingly, the U.S. Department of the Treasury is introducing Shariah into the U.S. banking system and society.

In short, it is clear that the U.S. government, and in particular the **U.S. Department of the Treasury**, is **engaged**—wittingly or unwittingly—in conduct calculated to **introduce shariah** not just into the U.S. banking and financial system, but into the society more generally. Given the wealth of information available to these officials about the critical threat posed by shariah to the existing U.S. system of law, their behavior has the effect of promoting a legal system demonstrably antithetical to the Constitution that can only be described as reckless and malfeasant.

Shariah is fundamentally about power, namely the enforcement of a body of law, not faith.... Shariah dictates a comprehensive and totalitarian system of laws, an aggressive military doctrine, an all-encompassing socio-economic program and a ruthless enforcement mechanism. It is, in short, a complete way of life....

U.S. policymakers, financiers, businessmen, judges, journalists, community leaders, and the public at large must be equipped with an accurate understanding of the nature of shariah and the necessity of keeping America shariah-free.

Let There Be Light

If we want to continue to enjoy the bright, warm light that Thomas Edison's incandescent bulb radiates, Congress will have to repeal Subtitle B of Title III of the Energy Independence and Security Act of 2007. Environmental "standards" will start eliminating 276 versions of incandescent light bulbs in 2012, and the drop-dead date for our favorite 100-watt light bulb is just one year away.

Then, we will only be able to buy more expensive but allegedly more energy-efficient lighting products such as **compact fluorescent lamps (CFLs)** that are supposed to reduce greenhouse gas emissions and force us to do our duty to save the planet. CFLs are also supposed to reduce our dependence on oil, but that's not persuasive because only 1 percent of our electricity is made by oil.

The **repeal bill** is called the Better Use of Light Bulbs (**BULB**) Act, introduced by Reps. Joe Barton, R-Texas, Michael Burgess, R-Texas, and Marsha Blackburn, R-Tenn....

No CFLs

CFLs are so toxic because of the mercury in the glass tubing that the cleanup procedure spelled out by the Environmental Protection Agency is downright scary. The EPA warns that if we break a CFL, we must take the pieces to a recy-

cling center and not launder "clothing or bedding because mercury fragments in the clothing may contaminate the machine and/or pollute sewage." **CFLs** must be rather **dangerous** if they will **pollute the sewage**.

CFL bulbs do not work well in colder temperatures, and most cannot handle dimmer switches. Broken CFL bulbs allegedly cause migraines and epilepsy attacks. Their supposed capacity to save energy is greatly exaggerated because, since CFLs do not emit as much heat, we'll have to compensate by turning up our thermostats in winter months.

Jobs go to China

The one result of CFLs we are sure about is that they export American jobs to China, where manufacturers enjoy the benefit of cheap labor. General Electric has already closed factories in Kentucky and Ohio, and [Dec.'10] it is closing its major light bulb factory in Winchester, Va., that employed 200 people....

Rep. Cliff Stearns, R-Fla., summed it up: "The misguided ban on incandescent light bulbs needs to be repealed. Banning a product that has been used safely for more than 100 years in favor of Chinese imported CFLs that pose considerable health risks is yet another example of more government intrusion into Americans' personal lives."

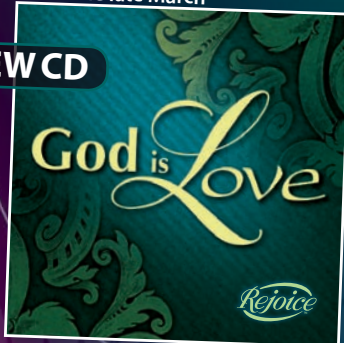

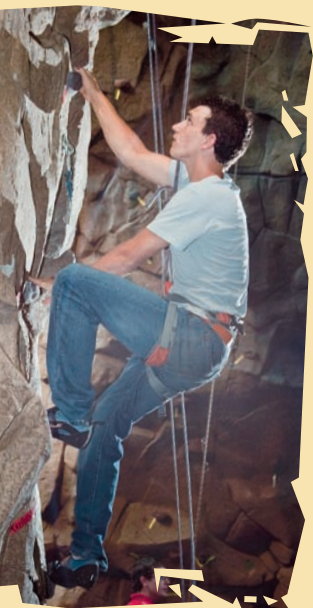
